## HAPPY NEW YEAR WORMING PACKAGE

There will be a price increase from the 1st January 2025 on the practice worming package. We continually try to keep our prices as low as possible, however due to ongoing price rises across testing kits and lab fees we have had to implement a small increase.

### WHAT'S INCLUDED

The package lasts for 1 year, is £110 and includes the following:

- 3 faecal egg counts (FEC) during the grazing season (i.e Mar-Oct)
- 1 retest of a FEC if resistance is suspected
- 1 tapeworm saliva test
- 1 small redworm blood test
- Detailed worming advice on all aspects including the recommended treatments (the actual wormers are at an additional cost)
- Use of the weigh bridge and body condition scoring on one visit during the year (other visits can be arranged during the year but are subject to an additional visit fee).
- Email reminders when tests are due

### ALTERNATIVE PACKAGE

We do offer an alternative package for £130 that includes a tapeworm blood test instead of a saliva kit for those individuals needing this option.

Registered Veterinary Nurses follow the Code of Professional Conduct. They are able to show you how to give medication, explain how the medications work, undertake monitoring diagnostic tests and give any other support you require. This can also include helping interpret worm testing results from external laboratories (subject to additional professional fees).
